
ACWR LEADERSHIP-CENTERED WEBINAR SERIES

HOW TO CHOOSE AN ARCHIVAL REPOSITORY

Is your community considering sending your archives to another repository, but you are not sure what options are available? This webinar will address the different types of archival repositories that exist and provide information about how to evaluate each program to ensure that they fit the needs and values of your community. UNDERSTANDING ARCHIVAL AGREEMENTS

Archival agreements are an important tool for building relationships between the community and the receiving repository. The agreement establishes the terms and conditions under which materials are given to the receiving institution and includes provisions for physical ownership, use of the collection, ownership of intellectual property rights, how to dispose of unwanted materials and any restrictions to the materials. Learn more about the different types and parts of archival agreements and things communities should consider when crafting an agreement with a receiving repository.

UNDERSTANDING ARCHIVAL RESTRICTIONS

Making archival collections available to the public is a balancing act—how do you balance peoples' right to privacy while making collections open to researchers. There are collections that need to be restricted, but it is rare that any one collection needs to be restricted in perpetuity. This webinar will focus on the question of what materials in your collection are restricted; what can remain open for researchers and how long certain materials might be restricted.
